NOTICE OF PUBLIC MEETING

Notice is hereby given that a virtual meeting of the Board of Managers of the Greater Harris County 9-1-1 Emergency Network (GHC 9-1-1) will be held on Wednesday, August 25, 2021 at 1:00 p.m. to advance the public health goal of limiting face-to-face meetings and thus slow the spread of the Coronavirus (COVID-19), for the purpose of considering and taking action on matters brought before the Board shown below.

On March 16, 2020, Governor Greg Abbott granted a request by the Texas Attorney General to waive certain requirements of the Texas Open Meetings Act to reduce face-to-face contact relating to government meetings while maintaining government transparency during government meetings in accordance with Section 418.016 of the Texas Government Code. Governor Abbott suspended various statutory provisions requiring government officials and members of the public to be physically present at a specified meeting location. The temporary suspension of these statutory provisions remains in effect.
