# **JOB DESCRIPTION:**

Monitor and Dispatch Public Safety Units. Answer incoming phone lines –emergency and nonemergency. Process and retrieve data from the TCIC/NCIC system, monitor incoming teletypes and other information as required by departmental and state guidelines. Maintain records in the Incode warrant system- Confirm/Serve. Trains new and existing employees as a normal course of their responsibilities. This is a safety sensitive and/or DOT position. As such, you will be required to participate in random drug testing at the city.

# **EXAMPLE OF DUTIES:**

#### ESSENTIAL DUTIES AND RESPONSIBILITIES:

- 1. Works a variety of schedules in a 24 hour, 7 day a week, communications center which includes, nights, weekends, holidays, and are considered essential personnel that must work through emergency situations including hurricanes and natural disasters.
- 2. Operates radio systems for Police, Fire, EMS, Fire Marshall, and after hour city services.
- 3. Operates a computer aided dispatch system in conjunction with radio system to dispatch appropriate field units via radio, relays information to mobile units, and receives and process information for departmental officials while constantly monitoring and maintaining contact with all field units.
- 4. Relays and updates necessary information to appropriate city departments and public safety agencies.
- 5. Answer incoming multi line Emergency 911 telephone calls and deliver lifesaving medical instructions when needed.
- 6. Process and retrieve data from the TCIC/NCIC system, monitor incoming teletypes and other information as required by departmental and state guidelines.
- 7. Trains new and existing employees as a normal course of their responsibilities.
- 8. Maintains specialized training certificates and licenses.
- 9. Performs other related duties as assigned by the Lead Communications operator or other Management personnel.

# **MINIMUM QUALIFICATIONS:**

- High School Diploma or equivalent required.
- Six months to one year related experience preferred.

- Ability to pass CritiCall computerized testing. CritiCall is software that tests dispatcher, call taker, and telecommunicator applicants for critical skills & abilities necessary for success in today's complex -- and stressful -- dispatching environment.
- Must have the ability to obtain Emergency Medical Dispatch Certification within one year of hire date.
- Must not have any tattoos that are on hands, neck, or face.
- Must possess current TCOLE (TCLEOSE) Basic Telecommunications Certification and have the ability to receive access from the National Crime Information Center. Please refer to the chart below to see if you are qualified to receive licensing.

# SUPPLEMENTAL INFORMATION:

#### **Additional Requirements**

The communications operator is frequently the first and sometimes only contact a caller has with emergency services. This contact subjects the Communications operator to public scrutiny and frequent criticism. While by no means all encompassing, the following is a short summary of the basic qualifications of a good Communications operator:

- Skills in operating a two-way radio, operating a computer and/or Computer Aided Dispatch system, operating a multi-line telephone system, and record keeping.
- Knowledge of Federal, State, and Local laws and ordinances
- Department policies and procedures
- City Geography
- Ability to handle multiple emergency situations simultaneously.
- Maintain the physical and mental conditioning required to work effectively under all conditions encountered.
- Ability to speak clearly, listens attentively, and remains calm during stressful situations.
- The ability to think clearly and act promptly in any emergency.
- A thorough understanding and knowledge of the Communications System.
- A very high level of professionalism.
- Willingness to accept the responsibility inherent in the position.
- Consistently provides the highest level of service possible to all communities and public safety agencies served by this Communications Center.
