

## NOTICE OF SPECIAL MEETING

Notice Is Hereby Given That A Special Meeting Has Been Called Of The Board Of Managers Of The Greater Harris County 9-1-1 Emergency Network (GHC 9-1-1). The Meeting Will Be Held On Wednesday, March 10, 2021 At 1:00 P.M. Virtually, To Advance The Health Goal Of Limiting Face-To-Face Meetings To Slow The Spread Of The Coronavirus (Covid-19), For The Purpose Of Conducting An Executive Session To Discuss The Executive Director Position And Consult With Attorney As Shown Below:

Due to the ongoing health and safety concerns related to the COVID-19 coronavirus, on March 2, 2021 Governor Greg Abbott issued Executive Order No. GA-34 encouraging all persons to use good-faith efforts to follow the COVID-19 health recommendations of the Texas Department of State Health Services which, among other things, provides individuals should not be in a group larger than 10 and, to the extent possible, minimize in-person contact with others not in the individual's household. On February 4, 2021 the Governor extended his original March 13, 2020 disaster declaration related to the COVID-19 coronavirus. Accordingly, the Board of Managers meeting for Greater Harris County 9-1-1 Emergency Network (GHC 9-1-1) will be held by videoconference pursuant to Tex. Govt. Code § 551.127 as modified by the decree of the Governor of Texas temporarily suspending certain provisions of the Texas Open Meetings Act.

As a result, persons wishing to observe the meeting of the Board of Managers may do so via videoconference or a tollfree telephone number.
